This release extends to any and all claims I have or later may have against the "**RELEASED PARTIES**" in any way related to whatsoever their performance of their chapter duties, whether or not such claims result from negligence on the part of any or all of the "**RELEASED PARTIES**," with respect to the **EVENT(S)** or with respect to the conditions, qualifications, instructions, rules or procedures under which the **EVENT(S)** are conducted or from any other cause. "A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which if known to him must have materially affected his settlement with the debtor."
